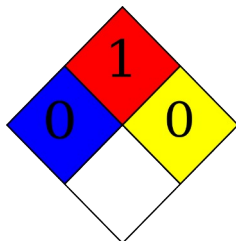
HEALTH HAZARDS: Does not present a risk of acute irritation, but may cause irritation after prolonged and frequent contact with eyes and skin.

4. FIRST AID MEASURES
